Solaris Rising, Inc. (“Solaris”) values your trust and is committed to the responsible management, use and protection of your information. This Privacy Policy describes the types of information Solaris collects from and about you when you visit our web site www.solarisrising.com (“Site”), and explains how Solaris may use and disclose such information, as well as your ability to control certain uses of it. The Information We Collect.

Information You Provide

Solaris collects personal information from you when you choose to share it with us. This may include information obtained when you create an online account with us, purchase goods, event tickets, enter contests, participate in surveys, post to message boards, participate in a chat room, request information from us, or otherwise contact us. The types of personal information that may be collected on these pages include name, address, age, date of birth, gender, e-mail address, telephone number, fax number, credit or debit card information, and information about your interests in and use of various services. We do not ask for, access, or track any location-based information from your mobile device at any time while downloading or using our mobile services.

Information Automatically Collected

As is true of most websites, we may use technologies such as cookies, web beacons, pixel tags, scripts, log files, or local shared objects (Flash cookies/HTML5), to collect certain information about visitors to our Site and interactions with our emails and online advertisements, and to allow Solaris to keep track of analytics and certain statistical information which enables Solaris

to improve its Site and provide you with more relevant content and advertising on our Site and other sites.

For example, we may automatically collect certain non-personal information from you, including but not limited to your Internet Protocol (IP) address, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamp, clickstream data, unique device identifier of any of your computer(s) or device(s) that are used to access the Site, and the domain name from which you accessed the Site. We also may collect information about your use of the Site, including the date and time you visit the Site, the areas or pages of the Site that you visit, the amount of time you spend viewing or using the Site, the number of times you return to the Site, other click-stream or site usage data, emails that you open, forward or click-through to our Site, and other sites that you may visit.

We partner with third party advertising networks to display advertising on our Site and to manage our advertising on other sites. Some of our advertising partners, marketing affiliates, or analytics providers may use technology such as cookies, web beacons, pixel tags, log files, or local shared objects (Flash cookies/HTML5) when they advertise on our Site, which may send these advertisers information including your non-personal information.

Tracking Options and California Do Not Track Disclosures

Certain parts of our Site require cookies. You are free to set your browser or operating system settings to limit certain tracking or to decline cookies, but by doing so, you may not be able to use certain features on the Site or take full advantage of all of our offerings. Please refer to your Web browser's or operating system's website or "Help" section for more information on how to delete and/or disable your browser or operating system from receiving cookies or controlling your tracking preferences.

Our system may not respond to Do Not Track requests or headers from some or all browsers. Please note that you may not be able to opt out of being served targeted advertising from certain ad networks, and you also will continue to receive generic ads.

Combination of Information

We may combine the information we receive from and about you, including information you provide to us and information we automatically collect through our Site, as well as information collected from other online sources or from third party sources (including social networks that you use to connect with Solaris) to help us tailor our communications to you and to improve our Site.

How We Use the Information.

Solaris may use the information we collect from and about you for any of the following purposes:

- To provide you with the services that you have requested. For example, if you purchase event tickets, or if you have entered a contest and win, we will send you an email notification confirming the sale or that you have won the contest;
- To respond to your inquiries, fulfill orders, and contact and communicate with you when necessary;
- To develop new products or services and to conduct analysis to enhance current products and services;
- To review the usage and operations of our Site and improve the design and content of our Site;
- To personalize your experience on the Site and provide you with customized Site content, targeted offers, advertising, on the Site or via email;
- To contact you with information, newsletters, and promotional or other marketing materials offering products or services from Solaris or on behalf of our partners, affiliates, or subsidiaries that we think you may be interested in;
- To use your data in an aggregated non-specific format for analytical and demographic purposes;
- To address problems with the Site or our business;
- To manage our telecommunications networks;
- To protect the security or integrity of the Site and our business;
- As otherwise described to you at the point of data collection; and
- To use and disclose your credit/debit card information only to process payments and prevent fraud.

Additionally, if you use the Site to connect with third party services you authorize us to use information from and about you, on your behalf, to interact with these third party services based on your requests.

How We Share Your Information.

We will share or disclose the information we collect from and about you with third parties only in the ways that are described in this Privacy Policy. We do not sell your personal information to unaffiliated third parties. We will only share your information in the following ways:

(a) if it is for the purpose(s) for which you provided the information; (b) with your consent; (c) as may be required by law or as we think necessary to protect our company, to protect others from

injury, or on matters related to public safety, as permitted by law, or otherwise as required by law (e.g.), in response to a court order or subpoena, in response to a law enforcement agency request, when we believe that someone is causing (or about to cause) injury to or interference with the rights or property of another, or when we believe that someone has violated our Terms of Use ; (d) with other persons or companies with whom we contract to carry out business, professional or technical support functions for us (e.g., service providers - see below); and/or (e) with our affiliated companies, subsidiaries, or divisions.

As we continue to develop our business, we might sell or buy subsidiaries, affiliates, assets, or other business units. If another entity acquires us or any of our assets, information we have collected about you may be transferred to such entity. In addition, if any bankruptcy or reorganization proceeding is brought by or against us, such information may be considered an asset of ours and may be sold or transferred to third parties. Should such a sale or transfer occur, we will use reasonable efforts to try to require that the transferee use personal information provided through this Site in a manner that is consistent with this Privacy Policy.

Solaris may also share aggregate or anonymous non-personal information with third parties, including affiliated companies and non-affiliated companies, for their marketing or analytics uses.

Sharing with Service Providers

Our operations and maintenance contractors sometimes have limited access to your information in the course of providing products or services to Solaris. These contractors include vendors and suppliers that provide us various products and services, including, but not limited to, credit card processing, e-mail distribution technology, live operator services, and/or content for the operation and maintenance of our Site. Access to your information by these contractors is limited to the information reasonably necessary for the contractor to perform its limited function for Solaris. We also contractually require that our operations and maintenance contractors (1) protect the privacy of your personal information consistent with this Privacy Policy, and (2) not use or disclose your personal information for any purpose other than providing us with products and services, except as required by law.

How You Can Access or Correct Your Personal Information.

If your personal information changes, or if you no longer desire our service, you may correct, update, amend, or remove it by making the change on our member account page, by emailing our Customer Service Department at help@solarisrising.com or by contacting us by telephone or postal mail at the contact information listed below. We will make every effort to respond to your request within thirty (30) days. To protect your privacy and security, we may take reasonable steps to help verify your identity before granting access or making corrections.

If you wish to subscribe to our newsletters or other periodic emails, we will use your name and email address to send the emails to you. You can view or change your subscription preferences at any time. You may choose to stop receiving our newsletter or marketing emails by following the unsubscribe instructions included in these emails, accessing the email preferences in your account settings page, or contacting us at 916-538-2248 and requesting to be removed.

Retention of Your Data

We will retain your information for as long as your account is active or as needed to provide you services. We will retain and use your information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

Information Security

Solaris is committed to handling your customer information with high standards of information security. We maintain physical, electronic and procedural safeguards that comply with federal regulations and generally accepted standards to guard your nonpublic personal information, both during transmission and once we receive it. When you enter sensitive information (such as a credit card number) on our order forms, we encrypt the transmission of that information using secure socket layer technology (SSL).

No method of transmission over the Internet, or method of electronic storage, is 100% secure, however therefore, we cannot guarantee its absolute security. If you have any questions about security on our Site, you can contact us at help@solarisrising.com.

Public Forums

Our Site offers publicly accessible blogs or community forums. You should be aware that any information you provide in these areas may be read, collected, and used by others who access them. In addition, we may receive certain information about you from a third party social network if you choose to link to us or use certain social media features, based on your registration and privacy settings on those third party services.

Send to a Friend

If you choose to use our referral function to tell a friend about our Site, we will ask you for your friend's name and email address. We will automatically send your friend a one-time email inviting him or her to visit the Site. Solaris stores this information for the sole purpose of sending this one-time email and tracking the success of our referral program. Children's Privacy.

Protecting children's privacy is important to us. Our Site is not intended for use by anyone under the age of 18. Solaris does not knowingly collect or store personal information from anyone under the age of 18. Premium services may not be used by anyone under the age of 18.
